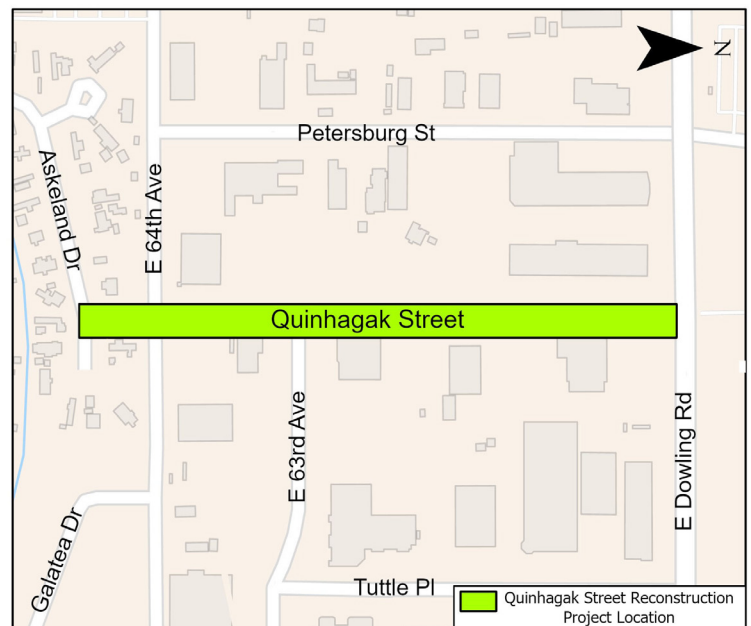

## CONSTRUCTION ANNOUNCEMENT

### CONSTRUCTION SCHEDULE & DETAILS

The Municipality of Anchorage (MOA) Project Management & Engineering Department (PM&E) is preparing to begin construction of the Quinhagak Street Reconstruction project from E. Dowling Road to Askeland Drive. See the map on the right for the project limits. **Construction will begin in late May or early June, depending on when seasonal weight restrictions are lifted. Work is tentatively anticipated to begin at E. 64th Avenue.**

MOA selected Mass Excavation, Inc. (MASS) to perform the construction of this project through the public bidding process. MOA and MASS's contact information is provided on the right. Both vehicular and pedestrian traffic along Quinhagak Street will be impacted at times during the project. Delays will be kept to a minimum, but drivers and pedestrians should anticipate detours and other temporary adjustments to the traffic pattern. Please obey all traffic control signage and personnel and if you have questions, please don't hesitate to contact a member of the project team listed here. Also see below for some additional general construction related items.



### CONSTRUCTION ITEMS

As construction begins, please be aware of arriving equipment. Residents and businesses should use caution when near or on the roadway during construction activities. Some general construction-related items to note include:

- The contractor will need to utilize the public Right-of-Way (ROW) to accomplish the work. Residents will not be allowed to park vehicles, motor homes, trailers, etc. within the ROW during construction. Conversely, the contractor has an obligation to generally maintain driveway access, except for occasional noticed periods of closure limited to 3 hours. The balance sought is to allow as much access as possible without compromising safety.
- The contractor may on occasion need to temporarily close lanes of the roadway to complete the work. Signage will be installed during these periods.
- The contractor's work hours will generally be from 7:00 AM to 6:00 PM Monday through Saturday. The Contractor may occasionally extend work hours beyond these times in order to complete critical ongoing tasks.

# QUINHAGAK RECONSTRUCTION PROJECT

The Municipality of Anchorage (MOA) is planning to upgrade Quinhagak Street from E. Dowling Road to Askeland Drive. Construction will begin in late May or early June, depending on when seasonal weight restrictions are lifted, as described in this construction newsletter. To sign up for project e-mail updates, please visit the project web page shown below.



Improvements will include a new roadway foundation, new asphalt pavement, new storm drain system, new pedestrian facilities, and improved street lighting. Additionally, all mailboxes along the project area will be replaced with new posts and mailboxes. The Contractor will be required to provide temporary mailboxes so that there is no interruption in mail service. Utility relocation work including natural gas, and cable facilities will also be occurring during construction.
